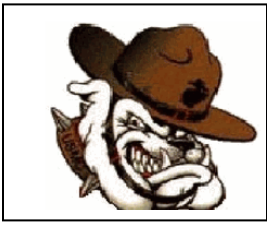

MILITARY NEWS

Attorneys Will Continue to Fight Dismissal of Marine Critical of Obama story from ABCnews.com

Civilian lawyers for the Marine sergeant discharged Wednesday for posting critical comments about President Obama on Facebook say they will continue to fight his dismissal in civilian courts.

On Wednesday, Sgt. Gary Stein was given an “other than honorable” discharge from the Marine Corps for disparaging comments that included labeling President Obama an enemy.

The Marines said the comments by the nine-year veteran were detrimental to good order and discipline and violated military law. Because of the “other than honorable” discharge, Stein will be demoted to lance corporal and be ineligible for most federal veterans benefits.

The conservative U.S. Justice Foundation and the American Civil Liberties Union say they will continue to fight Stein’s dismissal in federal courts.

They believe the Marine Corps overreached its authority and violated Stein’s First Amendments rights to free speech. Earlier this month, a federal judge denied their request for a temporary restraining order to block Stein’s dismissal.

Gary Krep of the U.S. Justice Foundation told ABC News that, once Stein has transitioned out of the Marine Corps in a few weeks, “we’ll be amending the complaint to reflect a request for relief for his reinstatement to the Marine Corps. “ Krep said his organization is committed to taking Stein’s case all the way to the Supreme Court if that’s what he wants.

David Loy, legal director of the ACLU of San Diego and Imperial Counties, confirmed that his organization would continue to pursue Stein’s case. He acknowledged that some of Stein’s language was “colorful and over the top,” but that he was speaking in a hypothetical abstract discussion when he said he would not follow a presidential order he considered unlawful.

Loy said Stein was “blowing off steam” and always said he would continue to do his job as a Marine even though he did not like President Obama. “He never said he wouldn’t do his job,” said Loy.

“You don’t lose your First Amendment speech rights in the military,” said Loy, who pointed to the precedent set by U.S. v. Wilcox. In that case, the Court of Appeals for the Armed Forces held that the First Amendment protected an Army paratrooper who identified himself as a white supremacist on a website.

Stein expressed his disappointment about his discharge on his Facebook page. “I have spent the last 9 years honorably serving this great nation and the Corps,” wrote Stein. “Even though I will be discharged no one can take the title of Marine away from me. I thank my family and friends for their support and love. Today is just the start of the rest of my life. Semper Fi.” Krep said Stein’s case has united groups from across the political spectrum because “free speech and due process rights are important.” He added, “It shows people who disagree on a variety of issues can come together, and that’s what we’re doing.”

Loy agreed noting that the ACLU works to defend civil liberties without regard to political affiliations.

Gov.: Hawaii to get 2,700 Marines from Okinawa

HONOLULU — The military is expected to announce it will transfer up to 2,700 Marines from the Japanese prefecture of Okinawa to Hawaii, Gov. Neil Abercrombie said Tuesday.

The governor didn't say when the Pentagon would announce the new plan. But he said he has talked with

the U.S. Pacific Command in anticipation of more Marines coming to Hawaii. He's also talked to Okinawa Gov. Hirokazu Nakaima.

"As the Pentagon finalizes its plans, I believe the number of Marines moving to our state will increase and we are well-prepared to receive them," Abercrombie said.

There are currently 7,500 Marines stationed in Hawaii.

The U.S. and Japan agreed in 2006 to move 8,000 U.S. Marines from Okinawa to Guam. But the countries have struggled to implement that plan amid opposition in Okinawa to a part of the deal that would keep a strategically important base — Marine Corps Air Station Futenma — within the prefecture.

U.S. lawmakers have meanwhile expressed concern about the high cost of boosting the military presence on Guam, a U.S. territory about 1,500 miles south of Tokyo and 3,700 miles southwest of Hawaii.

In February, Sen. Daniel Inouye told the Honolulu Star-Advertiser that the U.S. would instead move 4,000 Marines to Guam and send the rest to Australia and Hawaii.

Abercrombie indicated his experience in Congress working on legislation for military housing would help ease the move of Marines to Hawaii.

"In my role as governor, I am working to ensure that there is ongoing military and state cooperation to allow for a seamless and smooth transition for our servicemen and women and their families," he said.

In Washington, the top Democrat and Republican on the Senate Armed Services Committee on Tuesday cautioned Defense Secretary Leon Panetta that no agreement should be considered final without congressional approval.

"It is essential that we get these important decisions right, and that they be guided by sound strategic concepts and fiscally sustainable plans," Chairman Carl Levin of Michigan, ranking Republican John McCain

of Arizona and Democrat Jim Webb of Virginia wrote in a letter to Panetta.

The senators have criticized the original reorganization plans as impractical and costly, and included a provision in the defense budget for 2012 to make progress contingent on the Defense Department's first allowing an independent review.

VA Expands Medical Forms Program to Support Faster Claims Processing

WASHINGTON -- The Department of Veterans Affairs announced today the release of 68 new forms that will help speed the processing of Veterans' disability compensation and pension claims.

"VA employees will be able to more quickly process disability claims, since disability benefits questionnaires capture important medical information needed to accurately evaluate Veterans' claims," said Secretary of Veterans Affairs Eric K. Shinseki. "Disability benefits questionnaires are just one of many changes VA is implementing to address the backlog of claims."

The new forms bring to 71 the number of documents, called disability benefits questionnaires (DBQs), that guide physicians' reports of medical findings, ensuring VA has exactly the medical information needed to make a prompt decision.

When needed to decide a disability claim for compensation or pension benefits, VA provides Veterans with free medical examinations for the purpose of gathering the necessary medical evidence. Veterans who choose to have their private physicians complete the medical examination can now give their physicians the same form a VA provider would use. It is very important that physicians provide complete responses to all questions on the DBQs. VA cannot pay for a private physician to complete DBQs or for any costs associated with examination or testing.

"By ensuring relevant medical information can be found on one form, we will cut processing time while

improving quality,” added Under Secretary for Benefits Allison A. Hickey.

DBQ’s can be found at <http://benefits.va.gov/disabilityexams>.

The newly released DBQs follow the initial release of three DBQs for Agent Orange-related conditions. Veterans may file a claim online through the eBenefits web portal at <https://www.ebenefits.va.gov>. The Department of Defense and VA jointly developed the eBenefits portal as a single secure point of access for online benefit information and tools to perform multiple self-service functions such as checking the status of their claim.

Servicemembers may enroll in eBenefits using their Common Access Card at any time during their military service, or before they leave during their Transition Assistance Program briefings. Veterans may also enroll in eBenefits and obtain a Premium account in-person or online depending on their status.

Marines to cut four battalions, 12 air squadrons

Marine Corps said on Wednesday it would cut four infantry battalions and 12 flying squadrons over the next five years as it shrinks by 20,000 personnel to meet budget constraints and peacetime needs after more than a decade of war.

The biggest cuts would fall on Marine Corps bases in North Carolina, with Camp Lejeune and the adjacent New River air base losing 5,800 personnel and Cherry Point air base losing another 2,100. Three California Marine bases - Camp Pendleton, 29 Palms and Miramar - would lose a total of 6,000 personnel.

MARINE TIDBITS:

3 April 1945: On Okinawa, Marines of the III Amphibious Corps continued to make good progress all along their front, clearing Zampa Misaki and seizing the Katchin Peninsula, thus effectively cutting the island in two. By this date (D+2), III AC elements had

reached objectives thought originally to require 11 days to take.

5 April 1947: Five Marine guards were killed and eight wounded when attacked by Communist Chinese raiders near the Hsin Ho ammunition depot in Northern China. This last major clash between Marines of the 1st Marine Division and Communist forces occurred shortly after withdrawal and redeployment plans from China were issued for the 1st Division and 1st Marine Aircraft Wing on 1 April.

10 April 1959: Lieutenant Colonel John H. Glenn, Jr. was named as one of the original seven Project Mercury astronauts selected for space training. The seven astronauts, all volunteers, were selected by NASA from an initial group of 110 leading military test pilots. Three years later, on 20 February 1962, Col Glenn would become the first American to orbit the Earth.

12-13 April 1918: Marines of the 4th Brigade suffered their first gas attack on the night and early morning hours of 12-13 April when the Germans bombarded the 74th Company, 6th Marines near Verdun with mustard gas. Nine Marine officers and 305 enlisted Marines were gassed and evacuated, and 30 Marines died from the effects of the gas shells which hit in the middle of the reserve area cantonments in which they were sleeping.

15 April 1962: Marine Corps operational involvement in the Vietnam War began on Palm Sunday when HMM-362 with its Sikorsky UH-34s arrived at Soc Trang in the Delta south of Saigon. The task unit was called "Shufly" and its first operational employment involved lifting Vietnamese troops into battle.

18 April 1983: One Marine Security Guard was killed and seven were wounded when a large car bomb exploded just outside the U.S. Embassy in Beirut, Lebanon. Lance Corporal Robert McMaugh was standing guard at Post 1, just inside the front entrance when the bomb exploded outside the door. The explosion killed 61 people including 17 Americans. LCpl McMaugh was buried at Arlington National Cemetery on 26 April.

21 April 1951: Marine carrier-based airplanes made their first aerial contact with enemy planes over the Korean front lines. Captain Philip C. Delong shot down two YAK fighters and 1st Lieutenant Harold D. Daigh destroyed one more and damaged another in the heavily defended Pyongyang-Chinnanpo area. Both pilots were with VMF-312 flying from the USS Bataan.

27 April 1805: First Lieutenant Presley N. O'Bannon, who with seven other Marines was part of a force of Greeks and Arabs led by American Consul William Eaton, raised the United States flag for the first time over a conquered fortress of the Old World at Derne, a stronghold of the Tripolitan pirates. Two Marines were killed and one wounded in the assault on the walled city.

28 April 1993: The last A-6E Intruder departed from Marine Corps service. Marine All Weather Attack Squadron 332 transferred the last Marine A-6E to St. Augustine, Florida, and prepared for the squadron's transition to the F/A-18D and eventual movement from Cherry Point to Beaufort, South Carolina.

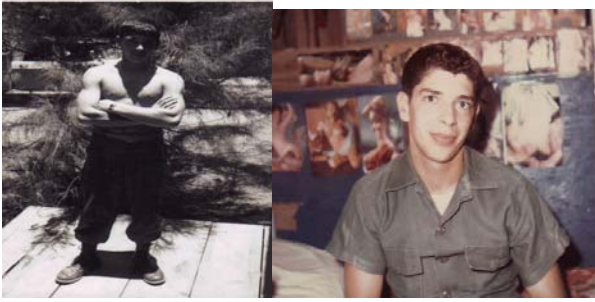

MEMBER OF THE MONTH

In March of 1967 just after turning 18, I received my draft notice. I didn't want to be drafted into the army and I really wasn't sure what branch of service I wanted to be in. My Dad was in the Navy and that was his recommendation for me. I wasn't all that excited about being out on the ocean on a large ship. I decided to join the Marines. My Dad was not happy, but he did wish me good luck. I talked to a Marine recruiter and he offered me the opportunity to work on Marine Aircraft if I enlisted for four years. I would be attending aviation structural school in Memphis, TN. after ITR.

In April of 1967 I arrived at MCRD Parris Island, S.C., An experience I never expected but soon accepted. I followed orders and graduated without incident. Actually, when I graduated in June, I did owe the senior drill instructor around 1,000 side straddle hops. Luckily, he let me slide.

In June of 1967 I completed my 4 weeks of ITR at Camp Lejeune, after this I went home to Boston for a few weeks. After my leave I reported to NAS Memphis for aviation structural mechanics school. For the next 6 weeks I trained on servicing the hydraulic systems of the A-F aircraft.

I graduated in September 1967 and received orders to Marine Corps Air Station, Cherry Point N.C. For the next seven months I worked on learning my job and servicing A-4 aircraft. Even though I enjoyed being stationed at Cherry Point, I really wanted to go to VietNam, I was craving for some excitement. I requested a transfer numerous times and finally, in April of 1968, I received orders for Viet Nam.

My family and friends were not as excited about me going to Viet Nam as I was. I was just pumped up about being a Marine and going to help in the war. When I arrived in DaNang in May of 1968, it was definitely a shock to my system. Not what I expected. It was hot, humid and it

smelled bad. After being processed I was assigned to the 1st Marine Air Wing maintenance squadron of MAG 12 in Chu-Lai, About 50 miles south of DaNang. Within the first few weeks our brand new PX was destroyed by a rocket barrage. Reality is setting in. While I was stationed at Chu Lai, I worked on the hydraulic systems of our TA4F's and since we were the Headquarters and maintenance squadron we worked on other Squadrons' aircraft as well. Quite often we had to borrow, beg, barter, and even make parts just to keep the aircraft flying.

When my time came to rotate home I was more than eager to leave. We were getting hit more frequently and with more intensity. During the TET offensive of 1969, We got hammered. The viet cong were walking rockets and mortar right down our flight line. We barely made it to our bunkers, which were located at the top of A revetment. I WAS, for the first time, really scared. The Viet Cong were actually getting more accurate with their aim. The final count for that day was devastating. If I recall correctly there were around 10 aircraft destroyed and 5-6 marines killed. I was counting down the days.

In June of 1969 I left Viet Nam behind. It was a great feeling. My family was really glad that I came home in one piece and so was I. We rarely talked about Viet Nam.

From July 1969 to March 1971 I was stationed at HQMC NAF Washington D.C. (Andrews, AFB) while there I serviced the T-33 shooting star jet trainer. For free time we organized a football team and a softball team. We had to compete against 3 navy teams and 6 Air force teams. The football team was not that good, but the baseball team was pretty good. As I recall we came in first place in softball the first year.

After four years in the Marine Corps I was discharged in March 1971. For the past 14 years I have been working for Hillsborough County as a Substitute teacher. I have two beautiful daughters; Amanda who is 25 and Courtney who is 21.
