



# Military absentee voting picks up

With little more than a month to go before the election, activity has picked up among military community voters overseas.

In the first three weeks of September, when free express military mail service became available for overseas service members and their families, 5,556 absentee ballots were sent to the U.S. with the military-only mailing service — a 65 percent increase over the same period in 2010, when the free express mail service was first authorized for the election season, according to the U.S. Postal Service.

Eric Eversole, executive director of the Military Voter Protection Project, said he is not surprised. "You would expect to see a sizeable increase in the number of absentee ballots being returned in a presidential year election as compared to a mid-term election," he said.

But Eversole is concerned that he is still seeing an "incredibly low number" of <u>absentee ballot</u> requests from across the U.S., according to some states he is tracking. For example, he said, Virginia has sent out 12,292 absentee ballots, compared to 41,762 sent in the 2008 cycle.

The number of Federal Post Card Applications that have been downloaded from the <u>Federal Voting</u> <u>Assistance Program website</u> has also picked up; about 527,000 had been downloaded as of Sept. 23, said Pentagon spokeswoman Navy Cmdr. Leslie Hull-Ryde. That's up by about 55 percent over the 341,000 that had been downloaded a month ago, but is still short of 2008 levels. The applications are used to <u>register</u> to vote and to request an absentee ballot.

As part of the Military and Overseas Voter Empowerment Act, states were required to send absentee ballots to those who had requested them by 45 days before the election — Sept. 22. That population includes military personnel and their families voting by absentee in the U.S. or overseas, as well as overseas citizens. "I would note that more service members received their ballots earlier this year than in 2008 because of the MOVE Act's 45-day requirement and the increased use of electronic mail delivery," Eversole said. "In other words, we should see an increase in ballots being returned earlier in the election window."

Army Lt. Col. Paul Amrhein, chief of the Soldiers' Programs Branch, Human Resources Command, said his office encourages troops to use the Federal Write-In Absentee Ballot (FWAB) if they have not received their absentee ballot from their local election official by 30 days before the election.

"This will ensure their vote counts on election day," he said.

Officials at the Federal Voting Assistance Program office encourage troops, family members and overseas citizens to also send that local ballot if they get it after sending in the FWAB. Local election officials will count only one of the ballots.

# Florida VA Embarks on Mission to Get Vets the Benefits They've Earned

Veterans' administrators in Florida are expanding their online services as a means to reach out to former activeduty military personnel residing in the Sunshine State that are not taking advantage of benefits they have earned.

Fewer than half the 1.65 million U.S. military veterans living in Florida are currently accessing state and federal benefits, ranging from the GI Bill to health care services, that they are eligible to receive, said retired U.S. Army Col. Mike Prendergast, executive director of the Florida Department of Veterans Affairs.

To get the Florida veterans aware of what they are eligible for, Veterans Affairs has rebranded its look online, is releasing <u>public service announcements</u> and has established a smart phone app for its new service personnel that have returned to civilian life.

"Some of Florida's veterans fought for our freedom in the days before television while others never knew a time without personal computers, yet they all share the admiration of a grateful nation," said Prendergast. "If they aren't receiving the benefits and services they rightfully earned, we must use every approach available to reach them and set things right."

Prendergast estimates that 40 percent of the veterans that have settled in Florida are using Veterans Affairs to access benefits.

Mark Alvarez, a Vietnam War veteran and the District 2 commander and Post 3308 commander of the Tallahassee Veterans of Foreign Wars, said many of the vets remain weary of entering the bureaucracy process they had experienced while in the military.

The state agency reports that Florida veterans draw more than \$13.7 billion a year in federal compensation, education and pension benefits, U.S. Department of Veterans Affairs medical services and military retired pay.

However, only 260,000 receive service-related compensation or a pension from the U.S. Department of Veterans Affairs. And currently, only one third of Vietnam veterans nationally are enrolled in VA health care or have applied for benefits they earned as a result of military service.

Florida has approximately 450,000 Vietnam veterans as citizens.

Women account for more than 140,000 of Florida's veterans, while 230,000 are veterans of operations Iraqi Freedom and Enduring Freedom.

# MARINE TIDBITS:

2 September 1945: The Japanese officially surrendered to the Allies on board the battleship *Missouri* in Tokyo Bay. With General Holland Smith transferred home in July 1945, the senior Marine Corps representative at the historic ceremony was LtGen Roy S. Geiger, who had succeeded Smith as Commanding General, Fleet Marine Force, Pacific.

5 September 1956: Eleven Marines from the 9th Marines, 3d Marine Division, stationed near Naha, Okinawa, drowned while swimming, from an undercurrent caused by Typhoon Emma. The violent storm, with 140 mph winds, struck the Philippine Islands, Okinawa, Korea, and Japan, causing some 55 deaths and millions of dollars in property damage.

6 September 1983: Two Marines were killed and two were wounded when rockets hit their compound in Beirut, Lebanon. Heavy fighting continued for the 24th Marine Amphibious Unit peacekeeping force in the area near their positions around the Beirut International Airport.

**8** September 1942: On Guadalcanal, the 1st Raider Battalion and the 1st Parachute Battalion, supported by planes of MAG-23 and two destroyer transports, landed east of Tasimboko, advanced west into the rear of Japanese positions, and carried out a successful raid on a Japanese supply base.

11 September 1992: Hurricane Iniki devastated the island of Kauai in Hawaii in one of the worst storms the islands had seen in over a century. Marines of the 1st Marine Brigade based at Kaneohe Bay, spearheaded Operation Garden Sweep, the massive cleanup effort.

*11 September 2001:* At 9:38a.m. a commercial airliner, piloted by terrorists, slammed into the Pentagon, the headquarters of the Department of Defense, located across the Potomac River from Washington, D.C. The

Marines Corps was fortunate in that no Marines were killed or seriously injured in this attack. The weekend before, most of the Department of Marine Aviation, located directly above the site of impact, had been relocated to another area of the Pentagon, during building renovation. Immediately following the attack, Marines set up a "command center" under an overpass of Interstate 395, which runs beside the Pentagon. Working alongside fellow servicemen and civilians for hours, days, and weeks after the tragedy, Marines played a large role in the rescue and recovery effort. Including those aboard the hijacked Boeing 757, 189 men, women, and children were killed in the terrorist attack on the Pentagon.

**15 September 1950:** The 3d Battalion, 5th Marines landed on Wolmi-do Island in Inchon Harbor and secured it prior to the main landing. The 1st Marine Division under the command of Major General Oliver P. Smith landed at Inchon and began the Inchon-Seoul campaign.

*16 September 1814:* A detachment of Marines under Major Daniel Carmick from the Naval Station at New Orleans, together with an Army detachment, destroyed a pirate stronghold at Barataria, on the Island of Grande Terre, near New Orleans.

*18 September 1990:* A new 40-acre training facility for Military Operations in Urban Terrain (MOUT) was dedicated at Camp Lejeune, North Carolina, by General Alfred M. Gray, Commandant of the Marine Corps.

20 September 1950: Marines of the 1st Marine Division crossed the Han River along a six-mile beachhead, eight miles northwest of Seoul, Korea. Five days later, the 1st and 5th Marines would attack Seoul and the city would be captured by 27 September.

24 September 1873: One hundred and ninety Marines and seamen from the USS *Pensacola* and *Benicia* landed at the Bay of Panama, Columbia, to protect the railroad and American lives and property during the revolution.

**27** September 1944: The American flag was raised over Peleliu, Palau Islands, at the 1st Marine Division

Command Post. Although the flag raising symbolized that the island was secured, pockets of determined Japanese defenders continued to fight on. As late as 21 April 1947, 27 Japanese holdouts finally surrendered to the American naval commander on the scene.

*30 September 1945:* Marines of III Amphibious Corps, commanded by Major General Keller E. Rockey, began landing in North China to assist the Chinese Nationalist government in accepting the surrender of Japanese forces and repatriating Japanese soldiers and civilians

# <u>Hero of the Month</u>

Combat Center Marine to Receive Navy Cross Posted on <u>May 18, 2012</u> by <u>itozer</u> on dodlive

A former Combat Center Marine will be presented with the nation's second highest award today in recognition of his courageous actions in Afghanistan. Sgt. Clifford Wooldridge will receive the <u>Navy Cross</u> from the Undersecretary of the Navy, Robert O. Work, during a ceremony in front of the members of his former Twentynine Palms-based unit, 3rd Battalion, 7th <u>Marines</u>.

Wooldridge, a Port Angeles, Wash., native, was serving as a vehicle commander on a mounted patrol, June 18, 2010, in the Musa Qala district of Afghanistan's Helmand province.

The patrol came under heavy enemy fire and then-Cpl. Wooldridge ordered his Marines out of their <u>vehicles</u> and they began to maneuver towards the enemy fighting positions. He led a four-man fire team to outflank the 15 Taliban fighters as they prepared to attack the rest of the Marine patrol.

Opening fire, Wooldridge and his Marines killed or wounded eight of the fighters, scattering the rest. As his fire team was withdrawing, Wooldridge heard voices from behind an adjacent wall of a nearby compound.

When he went to investigate the voices, Wooldridge found himself face to face with two Taliban fighters, whom he then killed with his weapon. Out of ammunition, Wooldridge crouched to reload his weapon when he saw the barrel of a Taliban machine gun appear from around the corner of the wall. Wooldridge grabbed the barrel and pulled the surprised fighter around the corner with it. The two began fighting hand-to-hand.

Realizing his predicament against the 220-pound former football player, the Taliban fighter attempted to pull the pin on a grenade in order to kill them both. Wooldridge used the fighter's own machine gun to kill him with several blows to the head.

For his bold actions that day and his courage under fire which disrupted the enemy attack on his platoon, Sgt. Wooldridge was decorated May 18, 2012 at Lance <u>Cpl</u>. Torrey L. Gray Field aboard the Combat Center.
