#### HERO OF THE MONTH

Belong to a prominent family from Philadelphia James Willing was a brother of a member of the first Continental Congress. Beginning in 1774 he lived and worked in Natchez, Mississippi along the Mississippi River. Willing was considered an average merchant who was slowly frittering away his family's fortune and growing more and more in debt. He was also a vocal agitator for the Revolution against King III and the English oppressors in America.

Willing returned to Pennsylvania in 1777 and early in the fall had several conferences with the Commerce Committee of the Continental Congress. Reportedly Willing drew a vivid picture of the probability of Loyalist (pro Crown) activity in the Natchez, Mississippi area and warned the Mississippi River would be closed to American traffic and further suggested an expedition to the lower Mississippi to enlist or compel the support of West Florida (remember Spain controlled the area that is now Florida, parts of Mississippi and Alabama, and Louisiana). The Commerce Committee, without the general knowledge of the Continental Congress, commissioned Willing a Captain in the Navy (although here's the deal, he was also referred to as an Army Officer as well as a Marine Officer by historians or whomever was (re)telling the story) and assigned him the expedition.

Willing's instructions were to deliver some dispatches for New Orleans, to bring up the Mississippi and Ohio part of the stores Spain had agreed to deliver at New Orleans for the use of the United States at Fort Pitt, and to "capture whatever British property he might meet with".

After receiving these instructions, Willing proceeded to Fort Pitt (Pittsburgh, PA). The armed boat Rattletrap was assigned to his command. On January 10, 1778, with a crew of about thirty men (both Marines and sailors) he set out on the westward voyage down the Ohio River. The river was partly frozen over and the river was difficult to navigate.

The commander for the English forces at Kaskaskia, Illinois upon hearing of the expedition believed that Illinois was to be attacked. Traveling down the Ohio (on the Rattletrap), Willing did seize animal pelts and a cargo of brandy (much to the delight of the enlisted Marines). The English commander interpreted these seizures as a

sign of what he might expect should the Americans come to Illinois in greater numbers.

By February 16th or 17th the expedition reached the plantation of Anthony Hutchins which was a short distance above Natchez, MS. Hutchins was made prisoner and his slaves and some other property seized. Rearming and refitting at the plantation's wharf Willing and the Marines proceeded on to Natchez.

On the afternoon of Friday, February 19th, Captain Willing and his command disembarked at Natchez. Orders were sent to all parts of the town that the residents should convene the following morning to be made prisoners of war, and that Willing would take possession of the jurisdiction. Mindful of their remoteness from protection (from either the Spanish or the English), the residents proposed that they would not take arms against the United States, nor help to supply or give assistance to its enemies if their persons, slaves and other property would be left secure.

On February 21 Willing signified that with the exception of the public officials of the Crown of Great Britain who held property he was in agreement with the proposal. The property of all British subjects not resident in this district was likewise exempted.

Most accounts of Willing's expedition say that his force embarked on "a career of confiscation and cruelty" as they moved south beyond Natchez. At Manchac, LA on February 23 an advance party of Marines and sailors captured the Rebecca, a British ship "mounted with sixteen guns, four pounders, beside swivels." The Rebecca had been sent to scour the Inland Passage and frustrate rebel attacks.

Leading his Marines and sailors Willing went on to seize other boats, raid plantations on the Mississippi, Thompson's Creek and Amite, and even followed some settlers into Spanish territory taking their property. It was reported that excesses and wanton destruction accompanied the seizures. Hogs were shot, cattle killed, bottled wine broken or confiscated, and dwellings burned. Along the lower Mississippi Oliver Pollock organized volunteers from New Orleans cooperated with Willing's men in plundering the British stores along the river.

Willing fostered the impression that a large army under General Clark was advancing on the colony. Instead of the thirty men who had started out on the Rattletrap, instead of the hundred or more of plunder-seeking adventurers that had joined along the way, the West Floridians (the Spanish) estimated the American forces at five to eight thousand.

By March Willing had reached New Orleans. Estimates of the plunder vary considerably, ranging from \$15,000 to \$1,500,000. Pollock reported that Willing took and sold 100 slaves worth 140 pesos each, and that proceeds from these and other plunder amounted to \$25,000. Another \$37,500 was profited by Willing and the Marines as they sold the Rebecca (which was armed as a war vessel). The physical damage done by the forces, however, was much greater than the meager profits secured.

The Americans presence in the Spanish owned and controlled New Orleans became a problem for Governor Gálvez. The British protested Willing's plundering on the lower Mississippi claiming it was Spanish territory. British war ships were sent to New Orleans to reclaim their property and defend British subjects. As a result of British reinforcement of West Florida and the establishment of a virtual blockade of the river Willing was stopped from sending supplies upstream to the Revolution (one of his missions) and the English bank of the Mississippi was lost back to the far numerous and armed English military forces.

With his avenues north endangered and having overstayed his welcome with Gálvez and Pollock, Willing became an extreme annoyance to the Spanish government. Willing's stay had now stretched into months. Pollock wrote the Congress expressing concerns about Willing's judgment and began developing ways for Willing and his men to return north, part by land and part by water through the Spanish Territories.

On July 14, 1778 Governor Gálvez issued a letter to the Spanish commanders along the Mississippi to allow Willing and twenty-five Americans (five Marines and sailors had been killed) to be allowed safe passage north. But with the settlers were so angry (by the destruction earlier in the year by Willing and the Marines coming south on the Mississippi) the journey north was too deemed to hazardous and no one took advantage of the opportunity. A month later Lieutenant Robert George, USMC requested permission to lead the men north through Spanish territory. Gálvez, upon receiving an oath that they would follow his route and not offend any English subjects along the way gave his permission. They traveled north by way of Opelousas, Natchitoches, and the Arkansas River. The Marines and sailors ended up in St. Louis where they

were placed under the command of Gen. George Rogers Clark.

Willing finally got away from New Orleans by sloop bound for Philadelphia. His journey home was an unfortunate one. The sloop was captured and Willing was taken prisoner. He was sent to New York. Toward the end of 1779 he was exchanged for British Colonel Henry Hamilton.

Willing's and the Marines actions succeeded in temporarily crippling the British naval forces on the Mississippi and interrupted the flow of supplies, mainly lumber, from Natchez to Pensacola and Jamaica (where most of the British ships in the Royal Navy were built or refitted).
