Lawmakers Blast Navy Over Lejeune Water

April 17, 2011 Mclatchy -Tribune News Service WASHINGTON -- Five members of Congress on Friday called the Department of the Navy to task again - for what they say is an apparent resistance to keeping veterans informed about past water contamination at Camp Lejeune in North Carolina. In a tartly worded letter to the Navy, Sen. Bill Nelson of Florida, Sens. Kay Hagan and Richard Burr and Rep. Brad Miller of North Carolina, and Rep. John Dingell of Michigan said the military continues to mislead the public about a high-profile scientific report on the contamination. They said that the Navy hasn't yet agreed to a deal that would allow federal scientists to review its public relations material.

VA/DOD Smart Phone App Helps Veterans Manage PTSD

WASHINGTON – Veterans dealing with symptoms of Post Traumatic Stress Disorder (PTSD) can turn to their smart phones for help anytime with the PTSD Coach application created by the Department of Veterans Affairs (VA) and the Department of Defense.

"This is about giving Veterans and Servicemembers the help they earned when and where they need it," said Secretary of Veterans Affairs Eric K. Shinseki. "We hope they, their families and friends, download this free app. Understanding PTSD and those who live with it is too important to ignore."

PTSD Coach lets users track their PTSD symptoms, links them with local sources of support, provides accurate information about PTSD, and teaches helpful individualized strategies for managing PTSD symptoms at any moment. The free PTSD Coach app is now available for download from the iTunes store and will be available for Android devices by the end of the spring.

"This application acknowledges the frequency with which our Warriors and Veterans use technology and allows them to get help when and where they feel most comfortable," said Assistant Secretary of Defense for Health Affairs Dr. Jonathan Woodson. The PTSD Coach is primarily designed to enhance services for individuals who are already receiving

mental health care, though it is certainly helpful for those considering entering mental health care and those who just want to learn more about PTSD.

"This is a great service we are providing to Veterans, Servicemembers, their families and friends, but it should not be seen as a replacement for traditional therapy," said VA's Under Secretary for Health Dr. Robert Petzel. "Veterans should utilize all of the benefits they have earned with their service and one of the best things about this app is it will get Veterans connected to the places that are out there to provide help."

The application is one of the first in a series of jointly designed resources by the VA National Center for PTSD and the Defense Department's National Center for Telehealth and Technology to help Servicemembers, Veterans, their families and friends manage their readjustment challenges and get anonymous assistance. Given the current popularity of mobile devices, VA and the Defense Department hope to reach tens of thousands of Veterans, Servicemembers, and their family members with the new suite of apps.

Veterans Crisis Line

VA is strategically rebranding the National Veterans Suicide Prevention Hotline (1-800-273-8255).

An important component of this comprehensive effort involves a new name: Veterans Crisis Line, which establishes a unique identity for this critical service.

Research influenced our decision to rebrand the service as a crisis line, changing the emphasis from

"suicide" to "crisis" for Veterans and their families to make that critical first call for help.

The Veterans Crisis Line is available 24/7/365 to provide confidential counseling and referrals for Veterans and their families.

Since its launch, the National Suicide Prevention Hotline has answered more than 390,000 calls and made more than 13,000 life-saving rescues

Rebranding Overview

VA and the Substance Abuse and Mental Health Services Administration (SAMHSA) continue to work together to ensure all Americans in emotional distress or suicidal crisis have a single confidential number to call for help. They provide a special service for Veterans through the SAMHSA-funded National Suicide Prevention Lifeline. Veterans and concerned family members can call the Veterans Crisis Line by dialing 800-273-8255 and "pressing 1."

The rebranding is an integrated national outreach effort to increase awareness and use of the Veterans Crisis Line and confidential online chat service, support and promote broader VA suicide prevention efforts, and promote help-seeking behaviors among Veterans at risk of suicide and other mental health problems.

This effort is the result of extensive research, including consultation with recognized authorities on suicide prevention and social marketing, key internal and external intermediaries who deal with Veterans every day, and Veterans themselves.

The rebranding will emphasize the "Press One" option for Veterans and family members who call the Veterans Crisis Line, ensuring their call is immediately transferred to VA's call center in Canandaigua, NY, which is staffed with professional responders trained and dedicated to serving Veterans and their families.

New messaging will reinforce the confidentiality of the Veterans Crisis Line for both Veterans and their family members, who may be the first to realize a Veteran is in crisis.

The Veterans Crisis Line's new look and feel will be incorporated into the campaign's collateral and promotional items.

VA is developing tools to aid its employees in sharing the Department's story about the Veterans Crisis Line, including outreach collateral, PSAs and educational videos, talking points, potential social media content, online banner ads for VA Medical Center sites, electronic posters, and story banks for the media.

Suicide prevention outreach efforts need to use carefully tailored and targeted messaging. Unlike outreach for many other health issues which rely on underscoring the prevalence of the problem, outreach for suicide prevention that emphasizes rising suicide rates among Veterans runs the risk of normalizing suicidal behaviors, helping to convince Veterans in crisis that considering suicide is a normal or even expected response to their challenges--and possibly leading to an increase in suicide attempts. Through this effort, VA will provide effective and safe messaging and outreach strategies that focus on affirming Veterans' strength and resilience and reinforcing help-seeking behavior.

VA understands the success of this program depends on support from internal staff, communities nationwide, and partnerships with groups like Veterans Service Organizations, community-based organizations, and local health care providers that have direct contact with Veterans every day. Many of these groups have participated in the campaign development and will be critical partners in the distribution of our messaging and efforts to build greater awareness for VA's critical services. We need your support and participation to help ensure all Veterans and their families are aware of the Veterans Crisis Line and the service its trained staff provide.

I don't know if you are aware of this great program for Veterans. It is the Pets For Patriots adopt a dog or cat from a local shelter/Humane Society. There web site is www.petsforpatriots.org

Any veteran or currently active duty, this service is available free of charge. Go on their web site, check it out, register by sending them a copy of DD214 (I blacked out my service number and or social security number for security reasons). They responded within 1 day with approval. I went to my local Humane Society (Who was on their list) found a dog we fell in love with and adopted him. The Humane Society here, as part of their participation in the program, waived the \$85.00 adoption fee!(Not sure if all counties do this but Columbia County does) When the adoption paperwork at Humane Society is complete they send a copy to Pets For Patriots to verify the adoption. Then Pets For Patriots will issue

you a \$150.00 gift card to Tractor Supply, PetSmart, and a couple of other pet chains so you can buy necessary dog food and dog items to get you going. As a member of Pets For Patriots this gift is renewed by them yearly. Also there are participating veterinarians who will give Pets For Patriots owners a 10 percent discount on their services.

I think this information would be great if it could be sent out to all the Detachments. It's great that an organization like this exists to help Veterans!

A Marine who was "Willing to Fight"

It is the custom of American Servicemen to write letters to loved ones BEFORE going into harm's way. A friend of mine from Northern Illinois recently told me about one such letter written by Marine Capt. Ryan Anthony Beaupre who was killed in a helicopter crash on March 20, 2003 during Operation Iraqi Freedom. It is well worth reading.

"Never was so much owed by so many to so few." Winston Churchill.

Mom & Dad,

Well if you are reading this, then things didn't go well for me over in Iraq. I'm sorry for the pain that I have caused you because of this. Please do not be upset with the Marine Corps, the military, the government, or the President. It was my choice to go into the military. The President and my higher commanders were just doing what they thought was best. Realize that I died doing something that I truly love, and for a purpose greater than myself. There is a paragraph that I read from time to time when I lose focus. "War is an ugly thing, but not the ugliest of things. The decayed and degraded state of moral and patriotic feeling which thinks that nothing is worth war is

much worse. The person who has nothing for which he is willing to fight, nothing which is more important than his own personal safety, is a miserable creature and has no chance of being free unless made and kept so by the exertions of better men than himself." John Stewart Mill

Now there is a little Marine Corps bravado in there, but I do believe in the basic premise. I want you to know that I could not have asked for better parents, or a better family. I'll never forget that one of my friends in elementary school said that if he could trade places with one person, he'd trade places with me because of my parents and home life. I truly feel that I've had a blessed life thanks to you two. Please give my love to Alyse & Ryan, Kari & Matt & the girls, Chris & Brandy, and everyone else in the family. All my love, Ryan

From Seaman Recruit to Master Chief Petty Officer. I joined the USN in Dec 1958, attended Boot Camp and Hospital Corps "A" School in Great Lakes, Il. I Always wanted to serve in the Navy, as I had an Uncle who I looked up to was a Destroyer Officer and a Cousin who served on Sub Chasers during WWII. At "A" School, most of my instructors were combat veterans from WWII and Korea, except for the Navy Nurses who instructed me in Nursing Care. My first duty station was a Training Air Station in Florida where I qualified to fly as a Search and Rescue Corpsman. I advanced to Petty Officer Second Class and attended the Medical Administrative School in VA when the Cuban Missile crisis broke out. I was assigned to the Naval Hospital Gitmo Bay, Cuba in 1962. While there, I became part of the Ground Defense Force in case Cuba decided to attack the Naval Base. I advanced to Petty Officer First Class. We were trained by the Marine Detachment in all tactics of self defense. I began my fondness for the USMC at that time because they were so dedicated and I read so many stories of the Marines in famous battles during the Pacific campaigns during WWII. Following my tour in Gitmo, I was assigned to the USS Newport News; an 8" gun Heavy Cruiser. Since we were the 2nd Fleet flagship of the Atlantic Fleet, we had a USMC Detachment on board. The crisis in Santo Domingo tasked us to deploy off the coast of

Santo Domingo and I was assigned to the Landing Party along with other Corpsman. We conducted small arms training off the fantail and the USMC Detachment was sent ashore to perform a security mission. My next assignment ashore took me to Savannah, GA in 1967 to the Navy and Marine Corps Reserve Training Center where I interacted with the I&I Staff as their only Corpsman. I was advanced to Chief Petty Officer and received orders to Vietnam in 1969 aboard the USS Sanctuary, one of two Hospital Ships operating off the coast of Vietnam. While assigned to the Hospital ship, I was tasked to go in country to the Medical facilities at the 1st Marine Division in Da Nang and the 3rd Marine division in Quang Tri Province by my Commanding Officer. It was during those Temp assignments that I got a close hand look at the USMC during combat operations. After my tour in Vietnam, I was assigned to the Naval Hospital at Camp Lejeune, NC in 1970 and again I found myself associated with the USMC. I was the Leading Petty Officer of the Surgical Team and deployed on field exercises with the USMC field medical units. I was advanced to Senior Chief Petty Officer in 1970, received a scholarship to a Junior College in Pensacola, FL. Upon graduation, I had to undergo training at the Field Medical Service School (FMF) at Camp Lejeune, NC prior to assignment to the First Marine Aircraft Wing, FMF PAC as the Wing Personnel Officer in Japan and participated in numerous deployments to Korea and Okinawa. In 1975, I transferred to the 2nd Medical Battalion, FMF LANT at Camp Lejeune, NC as the Battalion Personnel Officer where I was promoted to Master Chief Hospital Corpsman. I completed a tour of duty at the Training Headquarters and Medical Department Headquarters in Washington, DC as the Career Plans Officer and Command Master Chief where I dealt directly with the Medical Officer at HO USMC on Hospital Corpsman training issues. I had my final assignment in 1987 with the Defense Nuclear Agency, a Joint Service Command as Training Officer and Command Master Chief where I retired in 1989 with 30 plus years of naval service. As you can see my association with the USMC spans over 20 years and I would do it all over again. The Expiree de Corps that I experienced was immeasurable in terms of camaraderie and tradition.
