Libyan rebels claim victory south of Tripoli

TRIPOLI — Libyan rebels claimed victory over a suburb near Tripoli's airport on Saturday after an overnight battle as the opposition moves to solidify its hold on the capital while fighting Moammar Gadhafi loyalists in other parts of the country.

Residents of Qasr bin Ghashir, about 20 miles (30 kilometers) south of the capital, celebrated by firing guns and anti-aircraft weapons into the air and beating portraits of the toppled leader with their shoes. Regime troops had been shelling the airport from the area.

"You can say that bin Ghashir has been liberated from Gadhafi soldiers," said Omar al-Ghuzayl, a 45-year-old rebel field commander now in charge of forces at Tripoli's airport. "We've been able to push them completely outside Tripoli."

The celebration reflected the rebels' optimism after days of fierce fighting in the capital, which now appears to be largely under rebel control.

Gadhafi's whereabouts remain unknown. NATO and rebel fighters are focusing on his hometown of Sirte, his last major bastion of support.

But while fighting has died down, much of the capital remained without electricity and water. Streets are strewn with torched cars and stinking garbage. Corpses crowd abandoned hospitals. Stores are closed. Bombed planes sit on the Tripoli's airport runway.

"We have a huge shortage of gas," Tripoli resident Osama Shallouf said.

The shortages have made it difficult to bake the traditional pastries and buy new clothes to prepare for next week's Eid al-Fitr, the holiday that caps the Muslim fasting month of Ramadan.

"People will start celebrating when Gadhafi is caught," he said. "That will be our Eid."

Rebel leaders said Friday they'll establish a new interim government in the capital within 30 days, moving their headquarters from the eastern city of Benghazi, which fell into opposition hands early in the six-month civil war.

Mahmoud Jibril, the head of Libya's rebel National Transitional Council, said Friday the interim government needs about \$5 billion in frozen assets to pay state salaries and maintain essential services, including the army and police force.

A British official, who would only discuss the details on condition of anonymity, said Friday that his government hopes to release about 1 billion pounds worth (\$1.6 billion) of Libyan dinars printed in the U.K. to help the rebels. In March, Britain blocked the export of the bank notes, manufactured by a British currency printer.

The United States won approval on Thursday to release \$1.5 billion in frozen Libyan assets held in American banks. And U.N. diplomats are working on lifting a freeze on tens of billions of dollars for Libya.

The rebels' information minister, Mahmoud Shammam, has said some who worked in the Gadhafi regime but were sympathetic to the rebels will be welcome in the interim government, which could make the transition smoother.

"The only people we are going to exclude are the people who killed others and stole money," Shammam said.

Healing rifts won't be easy.

In the parking lot of an abandoned, bombed out fire station in Tripoli, Associated Press reporters saw rebels guarding four injured men they said were Gadhafi loyalists. Eventually, a rebel agreed to take as many wounded as he could fit in his pickup truck to a hospital, but was stopped repeatedly at checkpoints, where some kicked the prisoners, spat on them and tried to stop their transfer to the hospital.

Mohammed al-Egely, the rebels' justice minister, said he has visited detained Gadhafi fighters and that they were being treated according to international humanitarian law. He said the rebels are doing the best they can under the circumstances.

"We are in a state of war," he said. "Do you expect the fighters to bring them [prisoners] flowers? They are all fighting — and so there will be victims from each side."

International organizations have expressed concern about treatment of detainees on both sides.

Photo of dog at SEAL's funeral grips U.S.



DES MOINES, Iowa — A gripping photo of slain Navy SEAL Jon Tumilson's faithful Labrador retriever, Hawkeye, lying next to the Iowa native's flag-draped coffin last week has launched intense interest on the Internet and international media coverage. News photographers weren't allowed inside the Rudd-Rockford-Marble Rock gym for last Friday's service, which was attended by more than 1,000 people, including some of Tumilson's fellow SEALs. But his cousin, Lisa Pembleton, couldn't resist recording the striking image of Hawkeye, appearing to guard his slain master.

Hawkeye led the family into the gym for the funeral before accompanying Tumilson's friend, the dog's new owner, to the stage during the service.

Pembleton could not be reached for comment. She released a statement to California-based Home Post, a blog about military life and families, that read: "I hadn't planned on taking any pictures other than with family. However, from my seat at the funeral, I felt compelled to take one photo to share with family members that couldn't make it or couldn't see what I could from the aisle."

Tumilson, 35, who joined the Navy after graduating from high school in 1995, was among 30 Americans killed Aug. 6 when enemy forces in Afghanistan shot down a Chinook helicopter.

MCL collecting for family in base fire July 11, 2011 HOPE HODGE, Jacksonville Daily News

Members of a local veterans organization are collecting donations for a Camp Lejeune Marine whose wife and infant daughter were killed in a house fire aboard the base Friday afternoon.

Tara L. Lampman, 22, and her daughter, 6-month-old Lexi Lampman, were both in their Butler Drive duplex unit in Midway Park around 2:30 p.m. Friday afternoon, when the fire started. Marine officials said more than 20 personnel from base fire and emergency response units were on the scene within minutes, but the mother and daughter had already suffered severe injuries when they arrived.

The infant was pronounced dead at Camp Lejeune Naval Hospital that day; the mother, listed in critical condition, was first treated at the Naval Hospital and then transported to N.C. Memorial Hospital at Chapel Hill, where she died just after 4 p.m. on Saturday, Marine officials said.

The husband and father, Marine Cpl. Christopher B. Lampman, assigned to Combat Logistics Regiment 27, has reached out to members of the Onslow County Detachment of the Marine Corps League for assistance, MCL spokesman Jack Jackson said Monday.

Jackson said Lampman was an organization member and had been one of the league's committee heads since last summer.

"He came to us knowing that we'd be able to be that central support system for him," Jackson said. "He knows we take care of our own."

Jackson said Lampman's primary needs are new clothing and uniforms as well as funds to pay for funeral arrangements; the organization is asking for monetary donations so that the Marine can select the correct items.

According to releases from Camp Lejeune, Atlantic Marine Corps Communities has already arranged temporary lodging for Lampman and will move him and the other family in the duplex into new homes this week.

The fire, which severely damaged the Lampmans' living room and left smoke damage throughout the rest of the home, is still under investigation. 2nd Lt. James Stenger, a spokesman for 2nd Marine Logistics Group, said no new information on the fire or its causes was available Monday.

VA Creates Women Veterans Call Center Major Outreach Effort Launched

WASHINGTON – The Department of Veterans Affairs (VA) has embarked on a major initiative to reach out to women Veterans in order to solicit their input on ways to enhance the health care services VA provides to women Veterans. "We are taking a proactive approach to enhancing VA health care for women Veterans," said Secretary of Veterans Affairs Eric K. Shinseki. "We are seeking the input of women Veterans so that VA can continue to provide high quality health care to the growing numbers of women Veterans."

Representatives at VA's Health Resource Center (HRC) are placing calls to women Veterans nationwide, asking them to share their experiences with VA and suggest potential enhancements that will further VA's mission to provide the best care anywhere. Women Veterans are one of the fastest growing segments of the Veteran population. Of the 22.7 million living Veterans, more than 1.8 million are women. They comprise nearly 8 percent of the total Veteran population and 6 percent of all Veterans who use VA health care services. VA estimates by 2020 women Veterans will constitute 10 percent of

the Veteran population and 9.5 percent of VA patients. The HRC, which started placing calls on June 1, is contacting women Veterans who have enrolled, but have not begun using VA services. "Through this contact center, we are placing friendly, conversational calls to women Veterans," said Patricia Hayes, chief consultant of the VA's Women Veterans Health Strategic Health Care Group. "We want these Veterans and their caregivers to talk candidly about why they are not using VA, whether they are aware of the gender-specific services we offer, and what additional services they would like to see VA offer." The HRC representatives making the calls are also informing women Veterans about the services VA offers and quickly connecting them with appropriate departments if they are interested in trying VA health care. Veterans who have complaints about VA are connected to a patient advocate who helps resolve issues. VA has trained professionals in all aspects of women's health, including general primary care, osteoporosis management, heart disease, mental health care, menopausal services and obesity-related issues, such as diabetes. Preventive screenings for breast and cervical cancer are also areas in which VA excels. Soon, all VA facilities will offer comprehensive primary care for women from a single provider. The Women Veterans Health Care program has made significant changes in the last few years to enhance the health care offered to eligible women Veterans. This progress includes:

- Adopting key policies to improve access and enhance services for women Veterans;
- Implementing comprehensive primary care for women Veterans; ·
- Conducting cutting-edge research on the effects of military service on women's lives;
- Improving communication and outreach to women Veterans; and
- Providing mental health, homelessness and other services designed to meet the unique needs of women Veterans

Legislative Info.

I have gathered and summarized information regarding the recently ended State of FL Legislative session. There were several bill related to Veteran's submitted, in excess of 50, but only 6 that were passed and have or will become law.

For a full summary or text refer to the HB or SB number provided:

A Florida Veterans Hall of Fame will be established in the state Capital. Re: HB 0465

Gold Star Parents and Spouses of Vets KIA will be honored with free lifetime entrance to the 160 Florida State Parks. Re: HB 0095

Special recreational areas will be established in state forest for service disabled veterans to be able to hunt. Re: HB 0663

A person's status as a veteran may be displayed on a Florida driver license or ID card for a small fee and proof of the veteran's status with a DD214 military discharge document. Re: HB 1165 Allows active duty (incl. reserves) personnel that are deployed to receive a reduction of their FL property taxes for the time served in a combat area upon application and approval. SB 0592

Allows a voluntary contribution which goes to the DAV by anyone receiving or renewing their FL driver's license

Other Information:

--- The State House traditionally convenes in the spring of each year (usually April and May) for 60 days However next year in will convene in January to take up the topic of redistricting. Ideas, bills, and proposals will be received by your elected representatives as early as the fall. Contact your representative for exact details

VA Reaches Out to Veterans to Explain Upcoming Changes to GI BillEncourages Veterans to Visit VA Website to Learn More

WASHINGTON – The Department of Veterans Affairs (VA) is reaching out to inform Veterans of recent changes made by Congress to the Post 9/11 GI Bill that take effect in 2011.

General Allison Hickey, Under Secretary for Benefits, said "The Post 9/11 GI Bill is incredibly important because it reduces the financial burdens of higher education so that Veterans have an opportunity to achieve their education goals. VA believes it is important for Veterans to be aware of changes to the GI Bill this year and learn more about how these changes may affect them."

"It's hard to believe how far we have all come with the Post-9/11 GI Bill the past two years," stated General Hickey. "Today, more than 537,000 students have received over \$11.5 billion in GI Bill benefits to help them take charge of their future."

Upcoming changes to the Post-9/11 GI Bill effective August 1, 2011 include paying the actual net cost of all public in-state tuition and fees, rather than basing payments upon the highest in-state tuition and fee rates for every state; capping private and foreign

tuition at \$17,500 per academic year; and ending payments during certain school breaks, to preserve Veterans' entitlement for future academic semesters. Also, certain students attending private schools in select states can now continue to receive benefits at the same rate payable during the previous academic year.

Beginning October 1, 2011, eligible individuals will be able to use the Post-9/11 GI Bill for programs such as non-college degrees, on-the-job training, and correspondence courses, and they will be eligible to receive a portion of the national monthly housing allowance rate when enrolled only in distance learning courses.

VA is implementing the latest round of changes to the Post 9/11 GI Bill and has already begun processing fall 2011 enrollment certifications. Outreach by VA has helped to increase participation by colleges and universities in the Yellow Ribbon program, which helps students avoid out-of-pocket costs that may exceed the benefit. Today, more than 2,600 schools are participating in the Yellow Ribbon program. "VA is committed to ensuring Veterans have the information and tools they need to succeed," General Hickey concluded.

Examinations Based on Exposure to Contaminated Drinking Water at Camp Lejeune

BACKGROUND Veterans who served at U.S. Marine Corps Base Camp Lejeune, North Carolina, were potentially exposed to contaminants present in the base water supply prior to 1987. The chemical compounds involved have been associated by various scientific organizations with the possible development

of certain chronic diseases. However, many unanswered questions remain regarding the extent of base water contamination, the type and duration of exposure experienced by base personnel, and the likelihood that contaminant levels in the water supply were high enough to result in a particular disease. The Veterans Benefits Administration (VBA) issued Training Letter 11-03 on April 27, 2011, addressing processing disability claims based on exposure to contaminated drinking water at Camp Lejeune. This Fact Sheet is to notify compensation and pension (C&P) examiners of information that may be included in examination requests for Veterans with claims based on exposure to contaminated drinking water at Camp Lejeune.

EXAMINATION REQUESTS

- 1. Claims Based on Exposure Service connection for any disability claimed to have resulted from contaminated water exposure at Camp Lejeune requires sufficient medical evidence that the disability is related to that exposure. This medical evidence will generally come from a competent and qualified medical examiner who provides an opinion establishing a rational nexus or link between the claimed disability and the exposure. It is up to a competent medical authority, based on each Veteran's individual case, to determine whether it is at least as likely as not that the claimed disease or disability has resulted from the contaminant 2
- 2. Information Included with Examination Requests When examinations are requested, it should be kept in mind that these claims represent a unique situation for VA medical examiners. Examiners must determine, on a case-by-case basis whether a particular claimed condition is linked to contaminated water exposure. Therefore, when requesting examinations, regional offices will provide examiners with the documents listed below in order to assist examiners with their assessment and determination: Internet websites related to the issue of contaminated water at Camp Lejeune Diseases potentially associated with exposure to contaminants present in the Camp Lejeune water supply between 1957 and 1987 Websites describing potential health effects of exposure to chemical

- contaminants present in the water supply of Camp Lejeune between 1957 and 1987 Notice to Examiners Evaluating Claims Based on Service at Camp Lejeune.
- 3. Inadequate Examinations This information in the documents provided with the examination requests is intended to provide examiners with an adequate basis for providing a reasoned opinion. This opinion is a critical element for evaluating the claim. Therefore, if the examiner fails to provide a reasoned opinion and resorts to a statement such as "an opinion cannot be made without resort to mere speculation," the examination will be returned as inadequate.
- 4. Rescissions The Guidance in VBA Training Letter 11-03 supersedes the Camp Lejeune section of VBA Training Letter 10-03, Environmental Hazards in Iraq, Afghanistan, and Other Military Installations. As such, the information contained in the documents accompanying the examination requests replaces any prior documents or VBA Fast Letters received with examination requests for claims based on environmental exposures at Camp Lejeune.
- 5. References VBA Training Letter 11-03, Processing Disability Claims Based on Exposure to Contaminated Drinking Water at Camp Lejeune, April 27, 2011.

Houston Tucker announced he had 20 lottery tickets for the Marine Corps Tankers Association scholarship fund.


Several members of the Detachment were awarded the Distinguished Service Award.

HERO OF THE MONTH



For Lieutenant Colonel Anthony Henderson, it was a lifetime of service and professional development in the U.S. Marine Corps that prepared him to command 1,200 Marines in southern Afghanistan and engage in the most vicious combat fighting he had ever seen.

"Your preparations for those types of moments span your entire career," said Henderson. "At 18 years of education and training, it's what prepared me to listen and learn."

Just two months into his deployment in southern Helmand Province, Henderson, who was the Commander of 1st Battalion, 6th Marine Division, was tasked to devise a combat plan to overrun a historic Taliban stronghold in the Gamshir area known as the Jugroom Fort. Jugroom Fort was a 19th century British fort, built out of mud, which spanned five kilometers and was surrounded by tunnels, machine-gun bunkers, minefield and IEDs. It was typically defended by 200-400 Taliban fighters at any given point in time.

"It was a very complex attack. We had forces moving by land and air - plus we were coordinating with the British forces," said Henderson.

The mission began on April 28, 2008, and for the next month, there were several sustained battles as the ISAF forces slowly closed in on the area. The major combat operation commenced on May 28, 2008. Henderson led his Battalion to the southern end of Fort Jugroom, while still keeping his eye on the overall battle plan.

As Henderson's Battalion approached the Fort, the enemy began firing on the rear echelon trucks, essentially closing them in between the Fort and enemy fire. Henderson decided to push his men into the interior area of the Fort to engage directly with the enemy.

"Marines had to physically get the Taliban out of the Fort and it was the most vicious fighting I had ever seen," reflected Henderson. "The enemy had defensive positions in and outside the Fort, and grenades and rocket fire were exchanged between 10, 20 and 30 meters."

"There were fighters and Marines all over the place. The enemy was around everyone and everyone was around the enemy."

At this point, Henderson's men and the other one thousand Marines fighting at Fort Jugroom had been awake for two whole days with temperatures reaching 110 degrees. With 3-4-foot wheat fields surrounding the Fort, Henderson knew that fighting into the night would be dangerous - from the threat of enemy attacks and the heat.

"I grew up on a farm and I knew that wheat fields collect extreme heat. I had to make a decision that would result in the least amount of casualties," reflected Henderson.

As the firefight subsided, the Marines retreated to nearby shelter. However, the next day, intelligence reports indicated that the enemy was packing up and heading toward the Pakistani border. It became a major victory for the ISAF forces and Henderson's Marines.

"We spent the next two weeks clearing the Fort and the surrounding villages where the Taliban had stocked weapons and ammunition," said Henderson.

"For them, Jugroom was the final defense and there was nothing left to defend."

Henderson's tour in Afghanistan lasted six more months after the battle for Jugroom Fort. Two years later, he is stationed with the Joint Chiefs Regional Operations Staff in Washington, D.C., and Henderson can only wish to be back in Afghanistan.

"It's humbling and fulfilling to lead Marines," reflected Henderson. "I have a constant yearning to be back there and amongst them."
