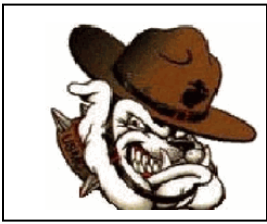

War crimes fugitive Mladic arrested in Serbia

Bosnian Serb military commander Gen. Ratko Mladic, center, smiles as he visits troops in June 1996 to mark the fourth anniversary of the founding of his Bosnian Serb army. Belgrade media reports on Thursday that Mladic, Europe's most-wanted war crimes fugitive, has been arrested in Serbia.

Summary of charges against Mladic

Under an indictment last amended in November 2009, the U.N. war crimes tribunal has filed these charges against former Bosnian Serb military chief Gen. Ratko Mladic:

- One count of genocide (in Srebrenica and elsewhere in Bosnia),
- One count of complicity in genocide,
- One count of persecutions on political, racial and religious grounds, extermination, murder, deportation, crimes against humanity;
- One count of murder, unlawfully inflicting terror upon civilians, cruel treatment, attacks on civilians, taking of hostages, violation of the laws or customs of war.

Pentagon: U.S. reducing troop total in Pakistan

WASHINGTON — The U.S. is reducing the number of its military personnel in Pakistan at that country's request following the killing of Osama bin Laden, according to the Pentagon.

A Pentagon spokesman, Marine Col. David Lapan, said Wednesday that there are more than 200 U.S. military personnel in Pakistan, but he provided no details on how many had been withdrawn since Pakistan made its request.

"We were recently (within past two weeks) notified in writing that the government of Pakistan wished for the U.S. to reduce its footprint in Pakistan," Lapan said. "Accordingly, we have begun those reductions." Lapan later said the personnel who have been pulled out were troops who had been training Pakistani forces in counterinsurgency skills. He did not say whether Pakistan had set a specific new limit on the U.S. numbers.

The U.S. also has military personnel assigned to the Office of the Defense Representative-Pakistan, based in Islamabad. Lapan said the total exceeds 200, but he was not more specific. He said that it has fluctuated

between 200 and 300 over time, depending on the training program being executed.

VA Processing Hundreds of Applications for New Family Caregiver Benefits in First Week

WASHINGTON – In the first week for open applications, the Department of Veterans Affairs (VA) has assisted more than 625 Veterans, Servicemembers and their Family Caregivers in applying for new services under the Caregivers and Veterans Omnibus Health Services Act 2010. “We are off to a good start having helped hundreds to apply, but we know there are thousands more who will qualify and need to apply today,” said Secretary of Veterans Affairs Eric K. Shinseki. “I encourage

eligible Veterans and their Family Caregivers to apply now to receive the benefits they have earned.”

New services for primary Family Caregivers of eligible post-9/11 Veterans include a stipend, mental health services, and access to health care insurance, if they are not already entitled to care or services under a health plan. The stipend portion of this service will be backdated to the date of the application.

Comprehensive Caregiver training and medical support are other key components of this program. VA began processing applications for eligible post-9/11 Veterans and Servicemembers to designate a Primary Family Caregiver on May 9, 2011. On top of receiving the 625 plus applications, Caregiver Support Coordinators have also assisted nearly 1,200 other Caregivers in finding more than two dozen other Caregiver benefits VA provides.

Applications can be processed by telephone through the Caregiver Support Line at (855) 260-3274, in person at a VA medical Center with a Caregiver Support Coordinator, by mail or online at www.caregiver.va.gov with the new Caregiver Application (VA Form 1010-CG). The website application also features a chat option that provides the Family Caregiver with a live representative to assist in completing the application form.

HERO OF THE MONTH

All veterans of any branch are the heroes of the month. As we celebrate Memorial Day, let us remember its meaning. I have taken excerpts of various parts of history for our remembrance.



General John Logan

In 1865, [Henry C. Welles](#), a druggist in the village of Waterloo, NY, mentioned at a social gathering that honor should be shown to the patriotic dead of the Civil War by decorating their graves.

In the Spring of 1866, he again mentioned this subject to [General John B. Murray](#), Seneca County Clerk. General Murray embraced the idea and a committee was formulated to plan a day devoted to honoring the dead.

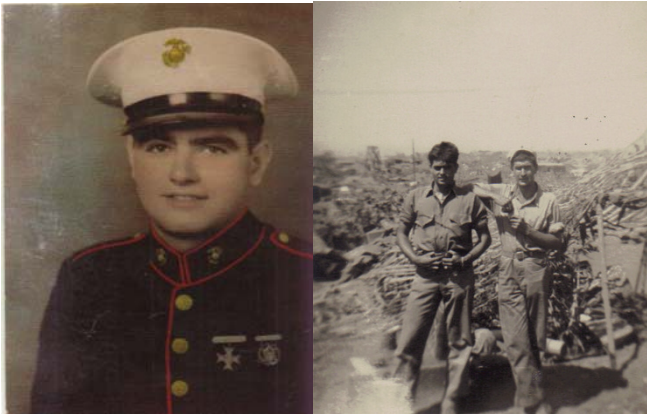
Townpeople adopted the idea wholeheartedly. Wreaths, crosses and bouquets were made for each veteran's grave. The village was decorated with flags at half mast and draped with evergreen boughs and mourning black streamers.

On May 5, 1866, civic societies joined the procession to the three existing cemeteries and were led by veterans marching to martial music. At each cemetery there were impressive and lengthy services including speeches by General Murray and a local clergyman. The ceremonies were repeated on May 5, 1867. The first official recognition of Memorial Day as such was issued by [General John A. Logan](#), first commander of the Grand Army of the Republic. This

was [General Order No. 11](#) establishing "Decoration Day" as it was then known. The date of the order was May 5, 1868, exactly two years after Waterloo's first observance. That year Waterloo joined other communities in the nation by having their ceremony on May 30.

In 1965, a committee of community leaders started plans for the Centennial Celebration of Memorial Day. The committee consisted of VFW Commander James McCann, chairman, American Legion Commander Oliver J. McFall and Mayor Marion DeCicca, co-chairman, along with Village Trustees, M. Lewis Somerville, Roscoe Bartran, Richard Schreck, Tony DiPronio, and VFW Vice-Commander, Kenneth Matoon. Their goals were: "to obtain national recognition of the fact that Waterloo is the birthplace of Memorial Day through Congressional action" and "to plan and execute a proper celebration for such centennial observance." In May of 1966, just in time for the Centennial, Waterloo was recognized as the "Birthplace of Memorial Day" by the United States Government. This recognition was long in coming and involved hours of painstaking research to prove the claim. While other communities may claim earlier observances of honoring the Civil War dead, none can claim to have been so well planned and complete, nor can they claim the continuity of observances that Waterloo can.

The Centennial Celebration that year brought dignitaries from government, military, veteran's organizations and descendants of the original founders of Memorial Day. A once luxurious home on Waterloo's Main Street, built in 1850, was purchased from the county and restored. Now the Memorial Day Museum, it houses artifacts of the first Memorial Day and the Civil War era. Memorial Day is commemorated each year in Waterloo. The parade, speeches, and solemn observances keep the meaning of Memorial Day as it was originally intended to be.

MEMBER OF THE MONTH:**SINK OR SWIM**

I arrived at San Diego Boot Camp on November 10, 1943. Soon after that elements of the 2nd Mar. Div. landed on Tarawa. Due to the large number of marines that drowned, the Marine Corps ordered all marines in boot camp to be qualified at swimming. The Marines that did not qualify were sent to a composite platoon for 10 days to qualify after graduation which is where I ended up. However, after the instructor tried to drown me twice. I qualified. I then received orders to Camp Pendleton with the K Bat. 4th Bn, 13th Marines 5 Mar. Div. It was not long before we were back in the pool. This time jumping from a 15 ft. tower pretending the pool was covered with oil, swim the length of the pool under water splashing the oil away as we came up for air. I MADE IT.

On September 4, 1944 we shipped out of San Diego for Camp Tarawa on the big Island of Hawaii. After three months of intense training and landings from LST's in ducks, the Sgt and four from each gun crew left for Hilo to board the LST 807. The ducks were manned by U.S. Army 471st Amphibian Truck Co. The rest of our gun crew was boarded onto an APA 211.

On January 15, 1945 our convoy left Hawaii for Eniwetok arriving on February 5th, then on February 7th to Siapan to allow the infantry to board the amphibian trackers on the LSTs. From there to

Two arriving on the 19th to sounds of Navy gunfire. This is when you begin to recognize every second. 3:00 a.m. Real steak and eggs were served; 9 a.m. we watched the first wave head for the beach and then 2 p.m. I boarded our duck. We left the ship for a long slow trip to the beach. When we reached the beach the beach-master waved us in.

When the front wheels hit the soft lava the duck could not get any traction to get out of the water and by now we were starting to draw fire. The beach master told us to back out till he could get a cat to bring us in. As we circled in the water a shell landed very close and just then a large wave hit the duck and started to flip over. Unfortunately I was sitting on the rail and was thrown into the ocean. It looked as if the gun and duck were coming over on me and my first thought was "Oh God not this way". Just then the wave broke and the duck pulled away from me. It was Sink or Swim and I swam to the beach. The sun was setting and we got into position and were ready to fire the next morning. At first light all hell broke loose. It is something I will always remember.

On March 16, 1945 it was announced the Island was secured and on the 27th we boarded transports and left for Hilo and Camp Tarawa. The war had ended. On August 22nd we left Hawaii for Japan.



I also was able to help oversee the dismantling of the Kamikaze suicide boats at Nagasaki. I left Japan on April 18, 1946 and was discharged on May 17, 1946.
